1. The parties are directed to file written submissions, not exceeding 20 pages, on the following—
 - a) In light of section 39(1) of the Constitution, whether this Court is obliged to consider the United Nations' International Covenant on Civil and Political Rights (Covenant) when construing sections 12(1)(b) and 35(3) of the Constitution;
 - b) If it should, what implications do articles 9 and 14(5) of the Covenant together with decisions of the Human Rights Committee have on the applicant's detention?
2. The written submissions must be lodged by—
 - a) The applicant and Democracy in Action on or before 13 August 2021;
 - b) The Commission, Helen Suzman Foundation and Council for the Advancement of the South African Constitution on or before 18 August 2021.
3. Further directions may be issued.
